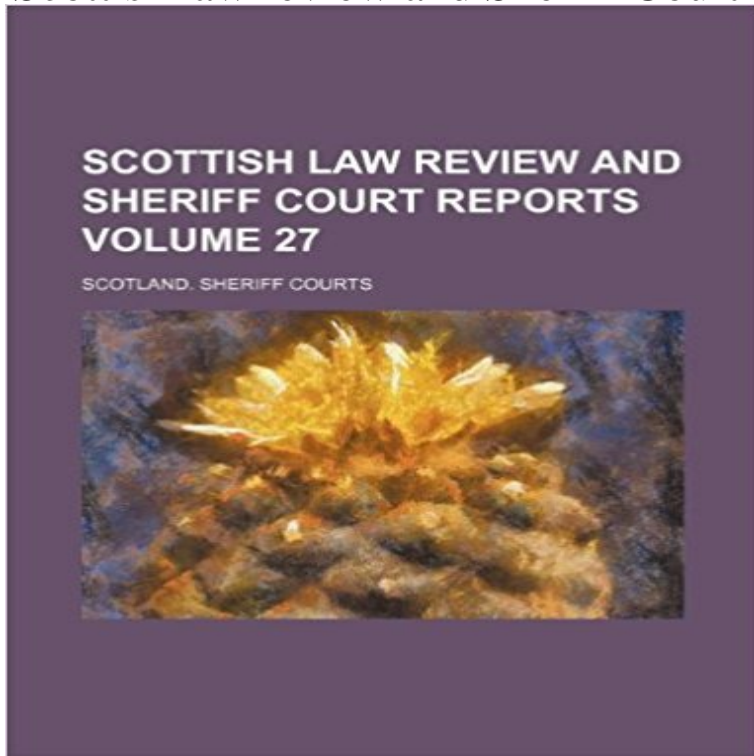

Held that in the circumstances the tender was equivalent to delivery, and plea that the action was not maintainable because of want of notice repelled. 3.
