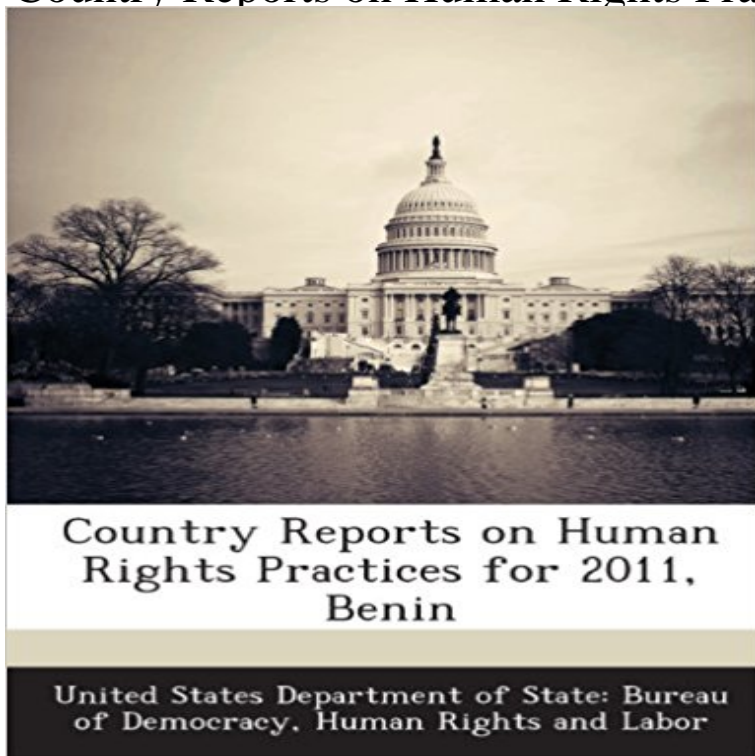


Country Reports on Human Rights Practices for 2011, Benin
