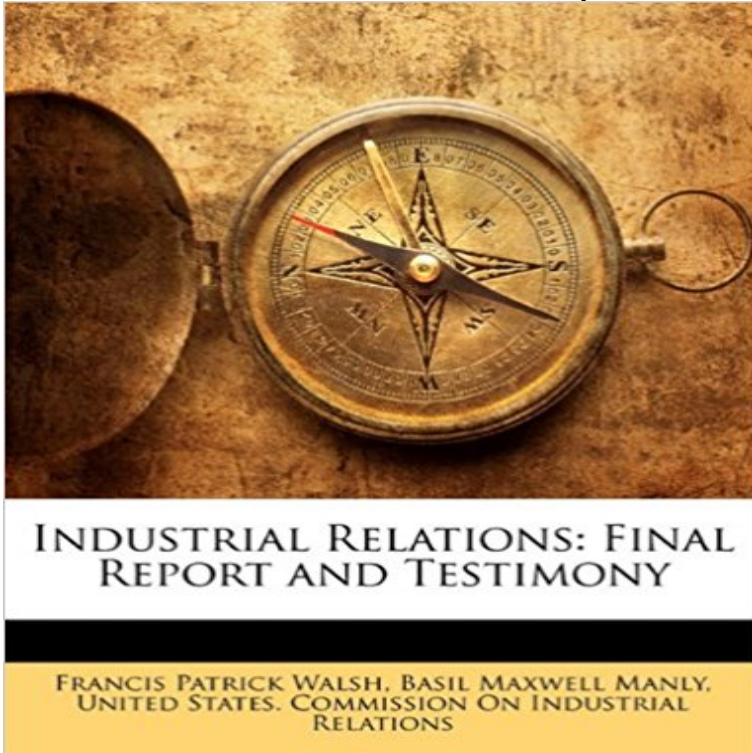


# Industrial Relations: Final Report and Testimony
