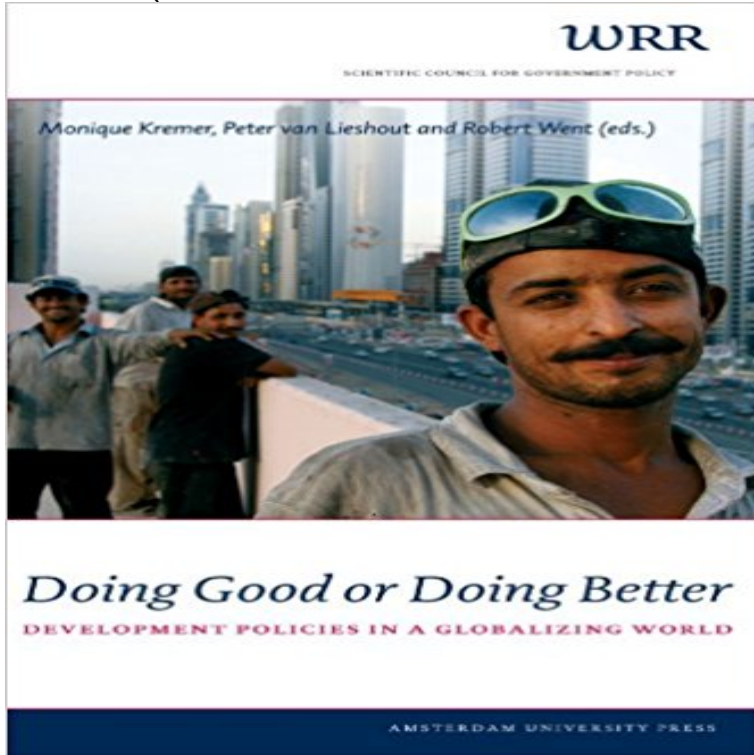


# Doing Good or Doing Better: Development Policies in a Globalizing World (Scientific Council for Government Policy -Wrr Verkenningen)
