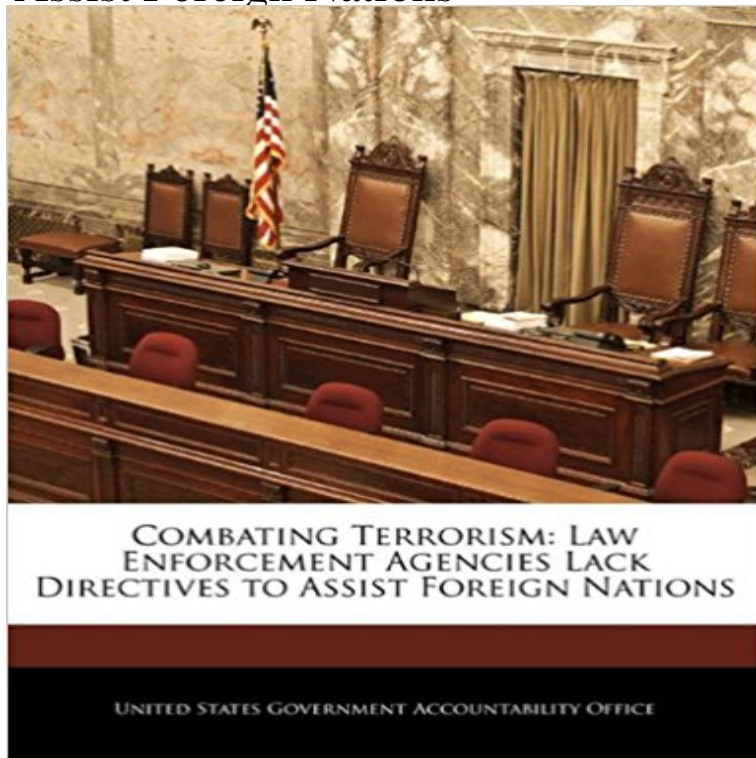


# Combating Terrorism: Law Enforcement Agencies Lack Directives to Assist Foreign Nations
