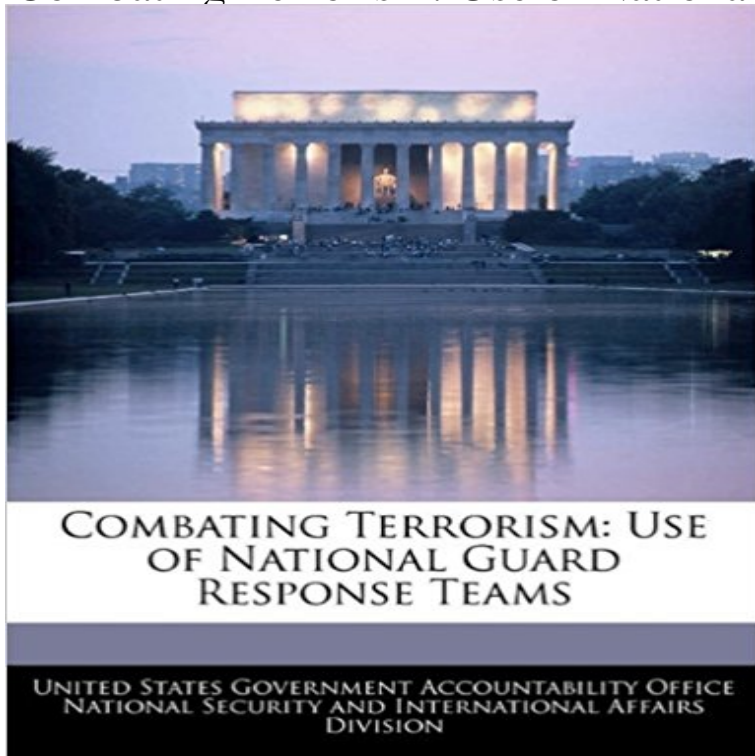


Combating Terrorism: Use of National Guard Response Teams
