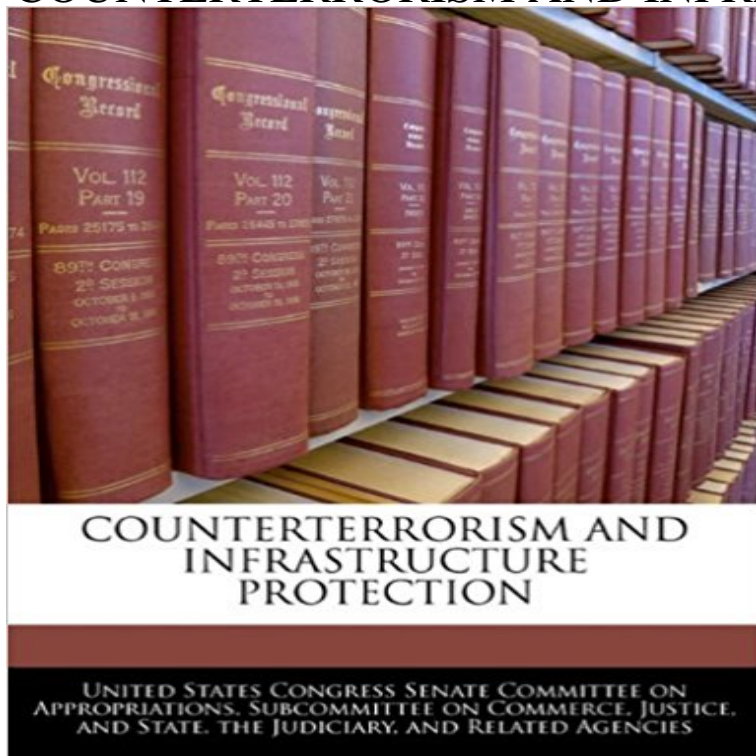


# COUNTERTERRORISM AND INFRASTRUCTURE PROTECTION
