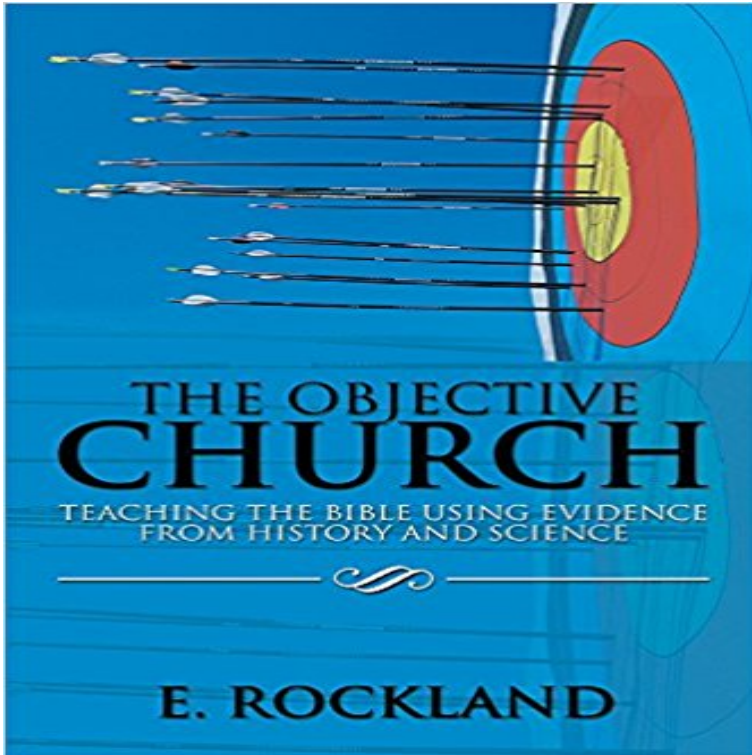

The Objective Church Teaching the Bible Using Evidence from History and Science The Bible is our ultimate guide for clues as we study events in the Bible and miracles. We will use the Bible as our guide when we study what happened to the Earth during the flood of Noah, what happened to Jonah during his three-day journey, what happened to Nebuchadnezzar during his seven-year punishment, and how God controlled the geophysical and historical events surrounding Alexander the Great. When God changed the physics or conditions, we may not be able to physically recreate the event because of the physics involved or the size of the change, but we may be able to reasonably determine what had to temporarily or permanently change. God does not need to change the laws of physics to accomplish His will. God can change the circumstances using the existing laws of nature to accomplish His will. Sometimes God accomplishes His will by directly changing or altering the laws of physics in nature. This is what most people typically refer to as a miracle. When God changes the physics, we can start with the Bible's description of what happened and use our understanding in science(s) to determine what specifically He changed in physics to perform the miracle. One simple example is when God prevented the shoes, clothing and, other possessions of the Israelites from wearing out during the forty-year exodus. Here, God temporarily change the second law of thermodynamics for only the Israelites and only during the exodus. Christianity is the only religion which is traceable, testable, and verifiable. A believer can explain the passages beyond metaphors and map the descriptive passages to real events involving real persons or groups, real things, real places in real time, and concrete knowledge. It is important to realize that the actual occurrence of an event in the Bible is

neither true nor false only if it has applicability to our lives. Spiritual truths speak to Gods mercy and grace and to our response and responsibility to God. Factual truths speak to His power, His existence, and His personal involvement in the world. Spiritual truths speak to ones relationship or lack of relationship with Christ. In the Bible, a factual truth is intrinsically related to a spiritual truth, but they are not the same. If all of the factual truths of the Bible were wrong, then all the spiritual truths would also be wrong because there would be no legitimate or authoritative basis for the Bible. Because our God is real, we in fact find much evidence for what He said occurred. The Bible is not full of myths and we do not follow fables, and this is why the Bible is reliable. The proof is in the evidence. When we teach the Bible, we should always strive to give a fuller understanding of what God actually did. The first part of the book covers the responsibility of leaders to answer questions, the list of frequent and important questions to answer, and then in chapters 5 and 6 we present one thorough answer to the always asked question If God is all powerful, then why does God allow pain and suffering to occur?
