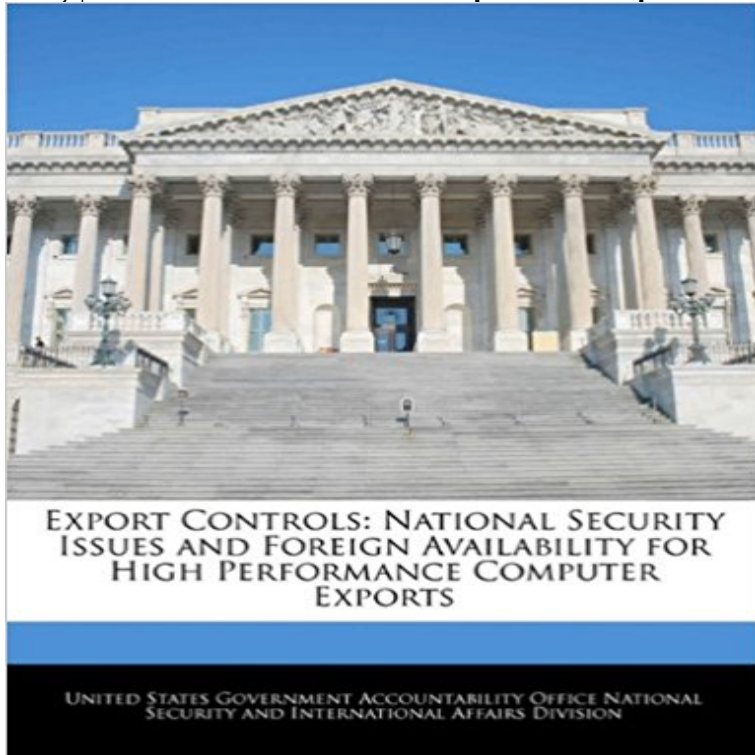


# Export Controls: National Security Issues and Foreign Availability for High Performance Computer Exports
