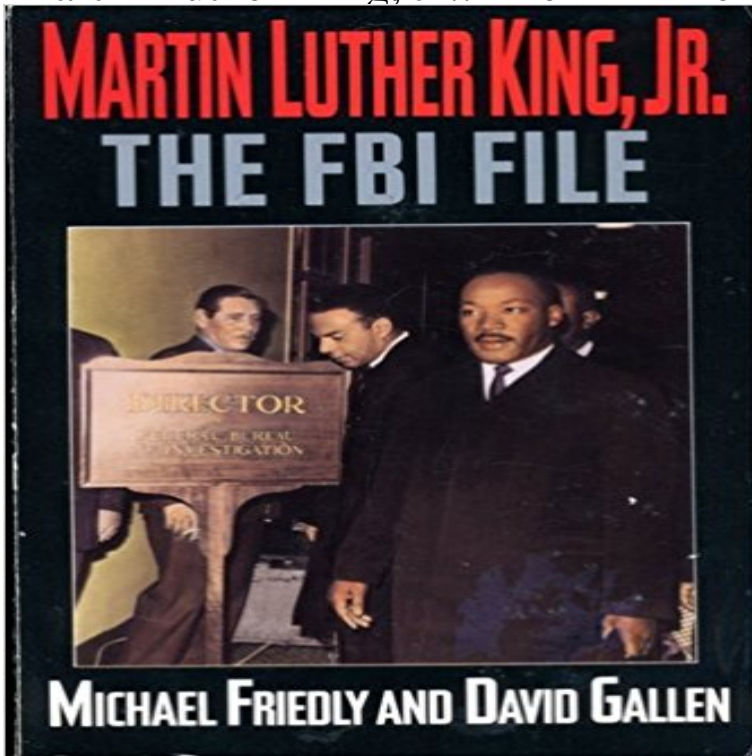


## Martin Luther King, Jr.: The FBI File
