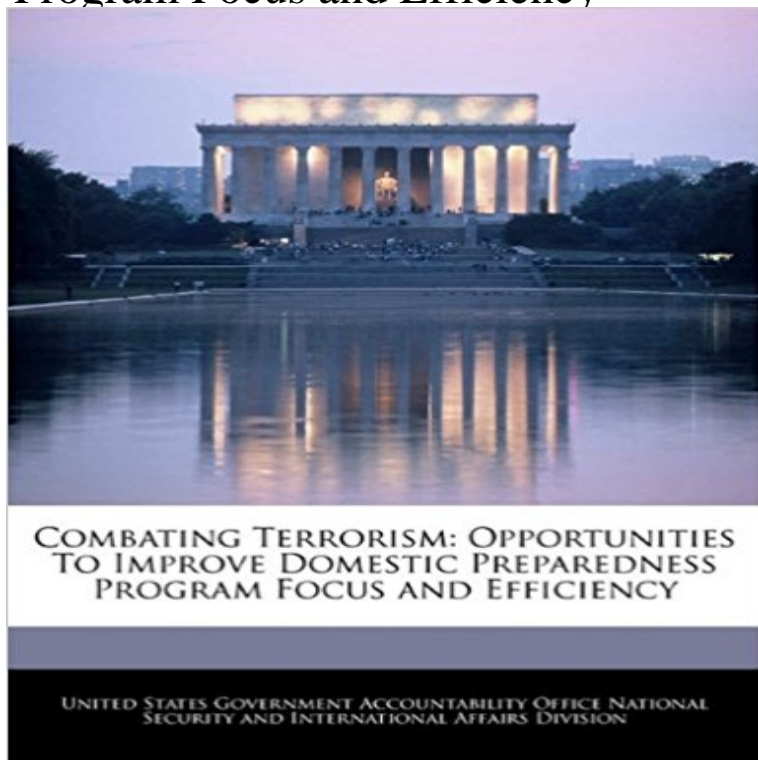


# Combating Terrorism: Opportunities To Improve Domestic Preparedness Program Focus and Efficiency
