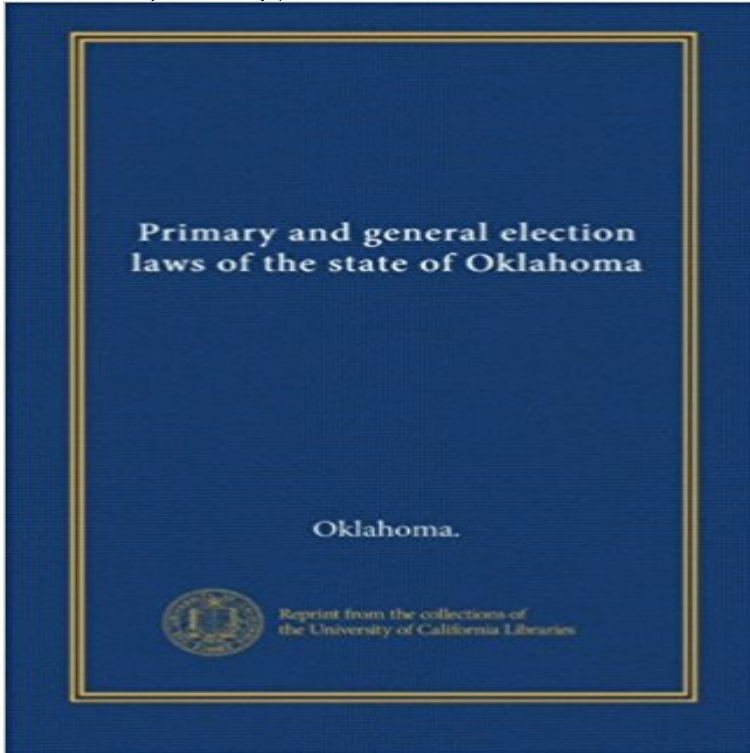


## Primary and general election laws of the state of Oklahoma
